an important member of the Association of Southeast Asian Nations, I believe that Brunei's influence will continue to grow and expand in Asia.

I visited Brunei Darussalam five years ago for ceremonies to observe the 20th anniversary of the establishment of diplomatic relations between the monarchy and Japan. It was my first visit to the country and I was very cordially welcomed, and I had an opportunity to have a significant exchange of views with the sultan and other leaders. Brunei, which has impressed me with its rich natural resources and verdure as well as its warm hospitality, has become one of my most favorite countries.

I would like more and more Japanese to visit Brunei and come to know its charms. The Japanese government last year

established a tourism agency to improve facilities to receive tourists from abroad, and I expect more people from Brunei to visit Japan and discover its wonders.

Visiting each other's country frequently is essential to building a close relationship, and most desirably, to create mutual understanding and respect. First of all, the Japan-Brunei Parliamentarians' League for the Promotion of Friendship is urging as many members of the Diet as possible to visit Brunei, and remains resolved to make every possible effort to further promote and strengthen the relationship between the two countries.

Last but not least, I say with great sincerity that I would like to extend my best wishes to Sultan Bolkiah and the people of Brunei Darussalam for their prosperity and development.

On the occasion of the 25th anniversary of the founding of Brunei Darussalam, I would like to extend, on behalf of the Japan-Brunei Parliamentarians' League for the Promotion of Friendship, my heartfelt felicitations to Sultan Haji Hassanal Bolkiah and the people of his state.

Brunei Darussalam has steadily been making progress, building a stable and affluent society on the strength of abundant natural resources. As

nies was reached, which led to Brunei Darussalam exporting its first LNG shipment to Japan in 1972. Since then, Brunei Darussalam, as the fifth-largest LNG supplier to Japan, has been steadily supplying its energy resources to Japan.

Japan on its part has contributed substantial investments in Brunei Darussalam, the latest being the MOU inked between Mitsubishi Corp. and the Energy Division of the Prime Minister's Office of Brunei Darussalam in August 2008. Under the MOU, both parties have agreed to work together to carry out the large-scale photovoltaic (PV) demonstration project called the Tenaga Suria Brunei project (TSB) in Brunei Darussalam. A PV system with a nominal capacity output of 1.2 MW will be installed at the Seria Power Station in the Belait district.

The project is expected to be commissioned in 2010. This project, apart from promoting the development of an alternative energy source,

will also create job opportunities and contribute to the diversification efforts in Brunei Darussalam.

Brunei Darussalam will continue to regard Japan as a major trading partner. Over the last 25 years, there has been a significant increase in trade between Brunei Darussalam and Japan. The increase is largely attributed to the export of oil and gas. Japan remains the dominant export destination, amounting to 40.8 percent of total exports, whereas more than 70 percent of Japan's exports to Brunei comprise of automobile-related trade.

The important trade relations between both nations were further reinforced when the Brunei Darussalam-Japan Economic Partnership Agreement (BJEPA) was signed in June 2007 and subsequently entered into force in July 2008.

The agreement is aimed at increasing new market opportunities and further developing strong economic ties

between the two countries. It was then followed by the inaugural meeting of the joint committee under the BJEPA, which was held July 31, 2008. The meeting was attended by Prince Mohamed Bolkiah and then Foreign Minister Masahiko Koumura.

Under the BJEPA, the two countries will further intensify cooperation particularly on capacity building through assistance and expertise from the Japanese side. Brunei Darussalam puts high emphasis on its human resources development and education with respect to creating an educated, highly skilled workforce. Such cooperation extended under the pact will contribute to Brunei Darussalam's economic diversification strategy.

Brunei Darussalam and Japan have been actively engaged in capacity-building programs and workshops in wide-ranging areas of cooperation organized in either country at all levels, encompassing government officials, private-


sector representatives, youths and students. The EPA is an important step to further increase the ties, and provide an avenue for the exploration of

port operator with extensive experience and currently managing 16 ports worldwide, has been selected to operate the new port, which is expected to be completed in 2012.

A Singaporean consortium, Sembcorp, has been appointed by the government to draw a master plan for PMB development. PMB offers many other investment opportunities in the petrochemicals, downstream industries and manufacturing sector. Investment opportunities will be available in ICT, aquaculture, tourism, logistics, as well as in infrastructure works such as port construction, dredging, reclamation, power generation, water supply, roads and bridge construction.

To support the initiative, Brunei is developing an Agro

Technology Park on a 263-hectare site, and investors are welcome to invest in the areas of research and development, commercialization in agriculture, horticulture, food and forest products, pharmaceuticals, cosmetics and aromatics.

ICT has been identified as one of the key catalysts for sustainable socioeconomic development and it will continue to be given priority. The government has allocated over 1 billion Brunei dollars in the National Development Plan 2007-2012 to the ICT sector, including allocation for human capacity building and e-business programs to further develop the SMEs' capability.

Several proposals from international companies, including some from Japanese, to manufacture halal pharmaceuticals are being followed up.

There is investment potential for ICT collaboration in




Economic exchanges lead to wide-ranging relationship

Also we would like to express our gratitude to Brunei Darussalam for its steady supply of energy resources to Japan for many years.



In July, the Japan-Brunei Economic Partnership Agreement came into force, and in January, Foreign Minister Hirofumi Nakasone and Foreign Affairs and Trade Minister Mohamed Bolkiah signed the agreement for the avoidance of double taxation, and the prevention of fiscal evasion with respect to taxes on income.

Incidentally, 2009 also marks the 25th anniversary of the establishment of diplomatic relations between Japan and Brunei Darussalam, which had become independent a little earlier.

Under such circumstances, I greatly hope that friendly relations between the two countries will be further promoted not only in the economic field but in various other areas.

Tokyo Electric Power Co. and Tokyo Gas Co. import liquefied natural gas from Brunei. The students also attended an exchange meeting with counterparts from Rikkyo University majoring in tourism.

We believe that these kinds of cultural exchange activities are very effective in maintaining and strengthening our friendship.

Brunei Darussalam, located on the northern shores of the Island of Borneo, is a peaceful kingdom rich in natural resources, including oil and natural gas. People have a high standard of living, and enjoy a rich cultural heritage and unspoiled natural beauty, which attracts foreign visitors with its Asian charms. Nearly 70 percent of the land is covered in luxuriant and pristine tropical rain forests in which there is a wide variety of rare plant and animal species. the establishment of a data center and disaster recovery center in the country. Brunei Darussalam is strategically located at the heart of ASEAN and has a well-developed web of international submarine cables, an abundance of capacity, state-of-the-art telecommunications systems, educated and skilled workforce, and suitable locations to support this project.

Complementing the government's efforts, the BEDB has established the iCenter — a center of excellence for nurturing and developing local entrepreneurs in the ICT arena. The center promotes key industries such as business solutions, mobile solutions and Internet applications, and currently accommodates 16 incubatees. It also provides com-

prehensive and effective incubation programs, entrepreneurship training, mentoring and marketing support.


Since its establishment, several incubatees have been able to penetrate overseas markets and inked deals with foreign companies, including one recently with Crestar Communications of the Philippines for the deployment of innovative technologies with applications in the commercial and public sectors in the country. The long-term vision is to create a dedicated technology park. A new building, the Knowledge Hub, is being built as a center for technology research and development with potential tenants from the Defense Ministry and the ICT sector.
