This visit also promoted better visibility and public perception of our country among the Japanese business community, which has shown keen interest in Cote d'Ivoire.

The rising number of Japanese businesspeople who take part in the economic and commercial events organized by the embassy, including the meetings held this year by the Ministry of Land, Infrastructure and Tourism within the framework of the dialogue on the development of quality infrastructure in Cote d'Ivoire, as well as the online seminar co-organized by the United Nations Industrial Development Organization Investment and Technology Promotion Office in Tokyo and the embassy is a perfect illustration of this interest.

I am rightly pleased with the dynamic that emerged through these multiple meetings aimed at promoting business and investment between our countries. These are dynamic economy with sustained growth; rich human capital; abundant natural resources available at competitive costs; a reliable energy supply; modern economic infrastructure; a business environment that is very attractive to investment; and a regional economic hub with a growing market and a regional stock exchange.

The main objective of NDP 2021-2025, which will hopefully reach ¥12.67 trillion, is to raise Cote d'Ivoire, by 2030, to the rank of upper middle-income countries.

In this regard, I would like to express my gratitude to UNIDO for its support and guidance in helping Cote d'Ivoire face the challenge of industrialization. Indeed, UNIDO has initiated Country Partnership Program 2022-2025, which supports NDP 2021-2025 to facilitate inclusive and sustainable industrial development.

In the context of the implementation of this program, there are opportunities for

Japanese companies to offer their experience and expertise. These companies, in association with Ivorian entrepreneurs who know the local market, should invest in the mechanization of agriculture, the processing of raw materials, the construction of hotels, ecotourism, beach and business tourism, social, medium- and high-standard housing, the construction of data centers and fiber-optic networks, the exploitation of natural resources, the construction of hydroelectric, solar and biomass power stations and the expansion of port terminals.
